Proposal:-

With reference to above Sl No 1, Rajiv Gandhi University of Health Sciences from the academic year 2024-25 Sri Adichunchanagiri Education Trust (R), B.G.S. Global Medical University Hospital and Research Center has offered a new B-Pharmacy course with an admission limit of 100 seats.

With reference to above Sl No 2, the Principal, Government Pharmaceutical Sciences Institution, Bengaluru for the academic year 2024-25 as per the report given by him. From line Sri Adichunchanagiri Education Trust (R), B.G.S. Global Medical Institution, Hospital and Research Centre, Bengaluru. Institutions have provided new facilities for starting B.Pharmacy course, Bengaluru, from the academic year 2024-25. PCI has been recommended that a letter of objection may be issued subject to the condition of obtaining their permission.

With reference to above S1 No 3 Dated: 20.07.2024 and held on 30.07.2024. From the academic year 2024-25 in the High Officer Committee meeting, Sri Adichunchanagiri Education Trust (Re), B.G.S. It was decided in the meeting that Global Medical College Hospital and Research Centre has issued no-objection certificate for starting a new B-Pharmacy course (60 seats only).

After scrutinizing the RGUHS report, Drug Controller's report and the available documents, the Government has approved the Sri Adichunchanagiri Education Trust (R), BGS Global Medical College Hospital and Research Centre has decided to give No Objection letter to start a new B-Pharmacy course (60 seats only). Hence the following order.

In view of the factors outlined in the proposal, from the academic year 2024-25 Sri Adichunchanagiri Education Trust (R), B.G.S. Global Medical College Hospital and Research Center Door No.67 Uttarahalli, Road, Kengeri, Bengaluru has issued a no-objection letter with 69 the following conditions to start a new B-Pharmacy course with an admission limit of 60 students.

The said organization shall comply with the following conditions:-

- 1. All necessary basic facilities and staff should be available before starting the B-Pharm course.
- 2 In the allotment of seats in Govt Organization have to adhere to rules/orders and Government quota seats should be given away.
- 3. The norms prescribed by RGUHS and PCI shall be followed compulsorily.
- 4. Instructions and orders issued by the State/Central Government from time to time shall be followed.
- 5. Any grant, financial support, from the Government of Karnataka to this college facilities are not provided. This is on a permanent non-subsidy basis subject.
- 6. The name and address of the college cannot be changed for any reason, without the prior permission of the Government/Authority.
- 7. Only such course fees as the Government may fix from time to time shall be collected from the students and seats shall be allotted to the Government in such proportion as may be fixed by the Government from time to time out of the seats sanctioned by the competent authority.
- 8. To ascertain the financial condition of the organization by the Drug Controller, Drug Control Department.
- 9. Violation of any of the above conditions imposed by the Government shall result in withdrawal of incorporation/sanction.
